The Station Fire Recovery Area begins at the intersection of Little Tujunga Road and the Angeles National Forest boundary, Township 3 N, Range 14 W, Section 33, San Bernardino Base and Meridian; then continues north along Little Tujunga Road to its intersection with the northern edge of Forest Service Road No. 3N17.7 (the Santa Clara Divide Road), Township 3 N, Range 14 W, Section 7; then continues east along the northern edge of Forest Service Road 3N17.7 to its intersection with Forest Service Road No. 4N37, Township 4 N, Range 13 W, Section 30; then continues north along the western edge of Forest Service Road No. 4N37 to its intersection with the Angeles National Forest northern boundary, Township 4 N, Range 13 W, Section 18; then continues east along the Angeles National Forest boundary to its intersection with the southern edge of Aliso Canyon Road, Township 4 N, Range 12 W, Section 8; then continues southeast along the southwestern edge of Aliso Canyon Road to its intersection with Forest Service Road No. 4N24, Township 4 N, Range 12 W, Section 16; then continues north and east along the southern edge of Forest Service Road No. 4N24 to its intersection with the western edge of Angeles Forest Highway, Township 4 N, Range 12 W, Section 2; then continues south along the western edge of Angeles Forest Highway to its intersection with Forest Road No. 4N20, Township 4 N, Range 12 W, Sections 11 and 12; then continues east along the southern edge of Forest Road No. 4N20 to its intersection with Forest Road No. 4N20A, Township 4 N, Range 11 W, Section 18; then continues south along the western edge of Forest Road No. 4N20A to the Desert Marksman Rifle Range, Township 4 N, Range 11 W, Section 18; then continues around the perimeter of the Desert Marksman Rifle Range to its intersection with Forest Road No. 4N20A, Township 4 N, Range 11 W, Section 18; then continues east along Forest Service Road No. 4N20 to its intersection with Forest Service Trail No. 4434W20 (Santiago 4x4 OHV Trail), Township 4 N, Range 11 W, Sections 8 and 17; then continues northeast along the northern edge of Forest Service Trail No. 4434W20 to its intersection with the eastern edge of Forest Service Road No. 5N04 (Little Rock Road), Township 4 N, Range 11 W, Section 3; then continues south along the eastern

edge of Forest Service Road No. 5N04.3 (Little Rock Road) to its intersection with South Fork Little Rock Creek, Township 3 N, Range 11 W, Section 1; then continues south and west along South Fork Little Rock Creek to its intersection with Forest Service Road No. 5N04.4 (Little Rock Road), Township 3 N, Range 11 W, Section 2; then continues southwest along Forest Service Road No. 5N04.4 to its intersection with Forest Service Road No. 3N17.2 (Pacifico Mountain Road), Township 3 N, Range 11 W, Section 10; then continues south along the eastern edge of Forest Service Road No. 3N17.2 to its intersection with Forest Service Road No. 3N14, Township 3 N, Range 11 W, Section 10; then continues south along Forest Road No. 3N14 to its intersection with the Charlton-Chilao Developed Recreation Area boundary, Township 3 N, Range 11 W, Sections 21 and 22; then continues south along the Charlton-Chilao Developed Recreation Area boundary to its intersection with Forest Trail No. 11W08 (Vetter Mountain Trail), Township 3 N, Range 11 W, Sections 33 and 34; then continues east along Forest Trail No. 11W08 to its intersection with Forest Road 3N16.1, Township 3 N, Range 11 W, Sections 34; then continues east along Forest Road No. 3N16.1 to its intersection with State Highway 2 (Angeles Crest Highway), Township 3 N, Range 12 W, Section 35; then continues north along State Highway 2 (Angeles Crest Highway) to the Devils Canyon Trailhead, Township 3 N, Range 11 W, Section 26; then continues east along Devils Canyon Trail to its intersection with the San Gabriel Wilderness boundary, Township 3 N, Range 11 W, Section 26; then continues east along the San Gabriel Wilderness boundary to its intersection with the major unnamed tributary that meets Bear Creek; Township 3 N, Range 10 W, Section 22; then continues south along the major unnamed tributary to its intersection with the main channel of Bear Creek, Township 3 N, Range 10 W, Section 36; then continues south along Bear Creek to its intersection with the San Gabriel Wilderness boundary, Township 2 N, Range 10 W, Section 13; then continues west along the San Gabriel Wilderness boundary to Cogswell Dam, Township 2 N, Range 10 W, Section 19; then continues south along the eastern edge of Cogswell Dam to its intersection with Forest Road No. 2N25.2 (West Fork – Red Box Road), Township 2 N, Range 10 W, Section 19; then continues west along the southern edge of Forest Road No. 2N25.2 to its intersection with Forest Service Road No. 2N24.1 (Rincon – Red Box Road), Township 2 N, Range 11 W, Section 26; then continues northwest along Forest Service Road No. 2N24.1 to its intersection with Forest Trail No. 11W28 (Rim Trail), Township N, Range 11 W, Section 27; then continues west along Forest Trail No. 11W28 to its intersection with

Forest Service Road No. 2N43 (Mt. Wilson Recreation Area), Township 2 N, Range 11 W, Section 29; then continues east along Forest Service Road No. 2N43 to its intersection with Mt. Wilson Road, Township 2 N, Range 11 W, Section 29; then continues along Mt. Wilson Road to its intersection with Forest Road No. 2N45 (Mt. Wilson Toll Road), Township 2 N, Range 11 W, Section 29; then continues south and west along Forest Road No. 2N45 to its intersection with Forest Trail No. 12W16 (Idlehour Trail), Township 1 N, Range 11 W, Section 6; then continues northwest along Forest Trail No. 12W16 to its intersection with Forest Trail No. 12W14 (Sam Merrill Trail), Township 2 N, Range 12 W, Section 27; then continues south along Forest Trail No. 12W14 to its intersection with Forest Trail No. 12W14A, Township 2 N, Range 12 W, Section 34; then continues northwest along Forest Trail No. 12W14A to its intersection with Forest Road No. 2N50.2, Township 2 N, Range 12 W, Section 34; then continues west along Forest Road No. 2N50.2 to its intersection with Forest Trail No. 2N65.2 (Chaney Trail), Township 2 N, Range 12 W, Section 33; then continues west along Forest Road No. 2N50.2 to Millard Campground, Township 2 N, Range 12 W, Section 33; then continues west around the perimeter of Millard Campground to its intersection with Forest Road No. 2N65.1, Township 2 N, Range 12 W, Section 33; then continues 0.9 miles west along Forest Road No. 2N65.1 to its intersection with private inholding, Township 2 N, Range 12 W, Section 32; then continues southeast along the northern and eastern boundaries of the private inholding to the Angeles National Forest boundary, Township 2 N, Range 12 W, Section 33; then continues west along the Angeles National Forest boundary to the starting point.
